#### ANCIENT MONUMENTS ACT, 1931.

Notice of Intention of the Commissioners of His Majesty's Works and Public Buildings to confirm a Preservation Scheme in respect of the Ancient Monuments known as the Roman Wall and Vallum ("Hadrian's Wall ") in the County of Northumberland.

Whereas by Section I of the Ancient Monuments Act, 1931, and subject to the provisions of that Section, the Commissioners of His Majesty's Works and Public Buildings (in the said Act and hereinafter referred to as the Commissioners) for the purpose of preserving the amenities of any ancient monument may prepare and confirm a preservation scheme for any area comprising or adjacent to the site of the monument and defined by reference to a map annexed to the scheme, being an area to which in the opinion of the Commissioners it is necessary or expedient for that purpose that the scheme should apply.

Now therefore the Commissioners give notice that they have prepared and intend to confirm a preservation scheme with map annexed for the purpose of preserving the amenities of certain parts of the Ancient Monuments known as the Roman Wall and Vallum which run across the County of Northumberland and comprise a stone wall with its ditch, camps, mile castles, turrets and subsidiary works and an earthwork or vallum running at various distances south of the stone wall.
