

In Parliament.—Session 1938-39.

COVENTRY CORPORATION.

NOTICE is hereby given that application has been made to Parliament in the Session 1938-39 by the Mayor Aldermen and Citizens of the City of Coventry for leave to introduce a Bill (hereinafter referred to as "the Bill") under the above name or short title. The title of the Bill is "A Bill to empower the Mayor Aldermen and Citizens of the City of Coventry to construct waterworks and street works; to confer further powers on the Corporation with regard to the health improvement and good government of the city; and for other purposes."

In accordance with the Standing Orders of Parliament a full notice containing a concise summary of the purposes of the Bill has been or will be published in the "Midland Daily Telegraph" of the 3rd and 10th days of December, 1938, and in the "Coventry Standard and General Advertiser for Warwickshire and the Midlands" of the 10th day of December, 1938.
