LAND DRAINAGE ACT, 1930.

*Brunstock Beck Drainage Board.*

NOTICE is hereby given that the Minister of Agriculture and Fisheries has made an Order under Part III of the Land Drainage Act, 1930, making provision for the extension of the period of office of the first members of the Brunstock Beck Drainage Board until the first day of November, 1939; and that the Order will become final and have effect as an Act of Parliament, unless within thirty-one days from the date of this notice a Memorial praying that the Order shall not become law without confirmation by Parliament is presented to the Minister by some person or body affected by the Order, and having an interest sufficient for the presentation of a Memorial.

A copy of the sealed Order has been deposited at the office of the Clerk of the Cumberland County Council, the Courts, Carlisle, for public inspection for a period of thirty-one days from the date of this notice, and may be inspected during the ordinary hours of business.

WE, the Ecclesiastical Commissioners for England, in consideration of Benefactions of capital sums amounting to £3,300 heretofore held by us for the spiritual benefit of the Parish of Fugglestone with Bemerton, in the County of Wilts and in the Diocese of Salisbury, and now specifically appropriated towards the endowment of the District of Saint Michael, Salisbury, which has recently been formed partly out of the said Parish of Fugglestone with Bemerton, do hereby in pursuance of the Act of the 29th and 30th Years of Her late Majesty Queen Victoria, Chapter III, Section 5, Grant out of the Common Fund under our control to the Minister for the time being of the said District of Saint Michael, Salisbury, and to his successors and when such District shall have become a New Parish then to the Vicar or Incumbent of such New Parish and to his successors, one yearly sum or stipend of £105, such yearly sum or stipend to be calculated as from the 7th day of November, 1938, and to be payable in equal quarterly portions on the 1st day of February, the 1st day of May, the 1st day of August, and the 1st day of November in each and every year: Provided always that the yearly sum or stipend hereby granted shall be and shall be taken to be in lieu of and in full substitution for the yearly sum or stipend of like amount heretofore payable by us towards the stipend of the Curate serving the Conventional District of North Bemerton, in the said Parish of Fugglestone with Bemerton, under the authority of Instruments which were sealed by us on the 18th October, 1934, the 17th October, 1935, the 15th October, 1936, the 14th October, 1937, and the 13th October, 1938, and were

respectively published in the London Gazette on the 30th October, 1934, the 29th October, 1935, the 30th October, 1936, the 29th October, 1937, and the 28th October, 1938: Provided also that if at any time lands or other hereditaments sufficient in our opinion to produce the said yearly sum or stipend of £105, or any part thereof, shall be annexed by us to the said District or New Parish of Saint Michael, Salisbury, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of the said yearly sum or stipend or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
