DISEASES OF ANIMALS ACTS, 1894 TO 1937.

Notice is hereby given in pursuance of Section 49 (3) of the Diseases of Animals Acts, 1894, that the Minister of Agriculture and Fisheries has made the following Orders:—

Order No. 5794.

(Dated 3rd January, 1939.)

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) SPECIAL ORDER No. 2 OF 1939.

SUBJECT.

I. Contracts the Foot-and-Mouth Disease Infected Area around Lowestoft, Suffolk, as from the 7th January, 1939, so as to comprise only the Area described in the Schedule.

II. Releases the Foot-and-Mouth Disease Infected Area around Lowestoft, Suffolk, from restrictions, and revokes Orders Nos. 5789 and 5790 as from the 14th January, 1939.

SCHEDULE.

Contracted Infected Area.

An Area comprising:—

IN THE COUNTY OF NORFOLK.

*In the petty sessional division of
Loddon and Clavering.*

The parishes of Burgh St. Peter and Wheat-acre; and so much of the parish of Aldeby as lies to the east of the London and North Eastern Railway line running from St. Olave's Station to Beccles.

IN THE COUNTY OF EAST SUFFOLK.

The boroughs of Lowestoft and Southwold.

*In the petty sessional division of
Beccles.*

The parishes of Worlingham, North Cove, Ellough, Willingham, Sotterley and Shadingfield; and so much of the parish of Henstead as lies within the petty sessional division of Beccles.

*In the petty sessional division of
Mutford and Lothingland.*

The parishes of Mutford, Rushmere, Gisleham, Kessingland, Barnby, Carleton Colville,

Oulton, Flixton, Blundeston and Somerleyton; and so much of the parish of Corton as lies to the south of the road running from Hopton to League Hole.

*In the petty sessional division of
Blything.*

The parishes of Benacre, Wrentham, Covehithe, Stoven, Brampton, Uggeshall, Frosten-den, South Cove, Reydon, Eastern Bavents, Wangford, Sotherton, Holton, Blyford, Henham, Thorington, Blythburgh and Walberswick; so much of the parish of Henstead as lies within the petty sessional division of Blything; so much of the parish of Westhall as lies to the east of the London and North Eastern Railway line running from Brampton Station to Halesworth; so much of the parish of Wenhaston as lies to the east and north of the road running from Holton via Mill Heath and Wenhaston Old Hall to Thorington Church; and so much of the parishes of Westleton and Dunwich as lies to the north-east of the road running from Black Heath via Butcher's Farm, St. Helena Farm, Bridge Farm and Dunwich to Dunwich Lifeboat Station.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) SPECIAL ORDER No. 3 OF 1939.

SUBJECT.

Declares the Area described in the Schedule to be an Infected Area for the purpose of preventing the spread of foot-and-mouth disease and applies the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 to such area.

SCHEDULE.

An Area comprising:—

IN THE COUNTY OF KENT.

The boroughs of Folkestone, Hythe, Lydd, New Romney and Tenterden.

The petty sessional divisions of Liberty of Romney Marsh, including its detached part, Ashford, including its detached part (*except the parishes of Molash and Chilham*), and Elham, including its detached parts (*except the parishes of Acrise and Stelling; and so much of the parish of Elham as lies to the east of the Southern Railway Line running from Lyminge to Canterbury and except the said railway line*).

*In the petty sessional division of
St. Augustine.*

So much of the parish of Waltham as lies to the south-west of the road running from Chartham via Thruxted, Upper Thruxted Farm, Waltham and Yockletts Farm to North Leigh.

*In the petty sessional division of
Bearsted.*

So much of the parish of Headcorn as lies to the south-east of the road running from Frittenden via Hungerden, Water Lane, Headcorn, Oak Farm and Burnt House to Boughton Malherbe.
