FOOT-AND-MOUTH DISEASE (INFECTED AREAS) SPECIAL ORDER No. 5, OF 1939.

SUBJECT.

Declares the Area described in the Schedule to be an Infected Area for the purpose of preventing the spread of foot-and-mouth disease

to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied.

SCHEDULE.

An Area comprising:—

IN THE COUNTY OF BERKSHIRE.

*In the petty sessional division of

The parish of Combe.

IN THE COUNTY OF SOUTHAMPTON.

The city of Winchester.

The boroughs of Andover, Eastleigh and Romsey.

The petty sessional divisions of Andover, Winchester and Romsey.

*In the petty sessional division of
Kingsclere.*

The parishes of East Woodhay, Ashmansworth, Litchfield and Woodcott, Whitchurch, Laverstoke and Overton; so much of the parish of Highclere as lies to the south of the road running from Tile Barn via Pound Street to the Newbury-Litchfield Road; and so much of the parishes of Burghclere, Ecchinswell and Sydmonton and Kingsclere as lies to the west and south of the following boundary namely:—the Great Western railway line running from Newbury to Litchfield as far as its junction with the road running from Burghclere Church via Sydmonton, Kingsclere and Sandford Farm to Wolverton and thence along the said road to Wolverton.
