

## IN THE COUNTY OF WILTSHIRE.

The city of Salisbury.

*In the petty sessional division of Marlborough and Hungerford.*

The parishes of Tidcombe and Fosbury and Buttermere; and so much of the parish of Grafton as lies to the south-east of the road running from Shalbourne via Marynear Farm, North Hill Barn, Wexcombe and Circular Plantation to Lynden Down.

*In the petty sessional division of Everley and Pewsey.*

The parishes of Collingbourne Kingston, Collingbourne Ducis, Chute, Chute Forest, Ludgershall, North Tidworth, Fittleton and Milston; and so much of the parish of Figheldean as lies to the east of the road running from Netheravon via Alton and Knighton Farm to Amesbury.

*In the petty sessional division of Salisbury and Amesbury.*

The parishes of Bulford, Cholderton, Newton Tony, Allington, Idmiston, Winterbourne, Durnford, Stratford sub Castle, Laverstock and Ford, Clarendon Park, Pitton and Farley, Winterslow, West Dean, Grimstead, Aldebury, Whiteparish, Landford and Redlynch; so much of the parishes of Durrington and Amesbury as lies to the east of the road running from Netheravon via Alton, Knighton Farm, Amesbury and Southmill Hill to Salisbury; and so much of the parishes of Britford, Odstock and Downton as lies to the east of the road running from Salisbury via Britford, Longford Park, Bodenham New Hall and Downton Post Office to Breamore.

**FOOT-AND-MOUTH DISEASE (INFECTED AREAS) (TEMPORARY MODIFICATION OF RESTRICTIONS) ORDER OF 1939.**

Permits the movement of animals, under licence, out of the Infected Area around Lisvane, Glamorgan, direct to a slaughter house in the Infected Area around Llanvihangel Gobion, Monmouth, or out of the last mentioned Infected Area direct to a slaughter house in the first mentioned Infected Area.

An Area comprising:—

**IN THE COUNTY OF KENT.**

The city and county borough of Canterbury.  
The boroughs of Dover, Margate, Ramsgate, Deal, Faversham and Sandwich.

The petty sessional divisions of Wingham, Ramsgate and Thanet, including its detached part.

The parishes of Sarre and Ringwoud.

*In the petty sessional division of Faversham.*

The parishes of Throwley, Ospringe, Graveney, Goodnestone, Faversham Without, Boughton under Bleau, Selling, Sheldwich, Leaveland, Badlesmere, Dunkirk and Hernhill.

*In the petty sessional division of Ashford.*

The parishes of Molash and Chilham.

*In the petty sessional division of St. Augustine.*

The parishes of Whitstable, Herne Bay, Chislet, Hoath, Westbere, Sturry, Hackington, Fordwich, St. Cosmus and St. Damian in the Bleau, Harbledown, Chartham, Thanington Without, Lower Hardres, Bridge, Patricbourne, Bekesbourne, Upper Hardres and Petham; and so much of the parish of Waltham as lies to the north-east of and including the road running from Chartham via Thruxted, Upper Thruxted Farm, Waltham and Yockletts Farm to North Leigh.

*In the petty sessional division of Elham.*

The parishes of Stelling and Acrise; and so much of the parish of Elham as lies to the east of and including the Southern Railway line running from Lyminge to Canterbury.
