### ROAD TRAFFIC ACT, 1930.

NOTICE is hereby given that on the 31st December, 1938, the Minister of Transport made an Order under Section 46 (3) of the Road Traffic Act, 1930, amending the provisions of the Borough Council of Ealing Roads (Restriction) Order, 1938, which prohibited subject to certain exceptions the driving of locomotives, motor tractors, heavy motor cars and motor cars with seats for more than seven persons exclusive of the driver on St. Annes Gardens and Iveagh Avenue, Ealing.

The effect of the amending Order is to remove the restrictions on Iveagh Avenue.

## LONDON PASSENGER TRANSPORT ACT, 1937.
