ROAD HAULAGE WAGES ACT, 1938.

HOLIDAYS WITH PAY ACT, 1938.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Labour, after the expiration of at least forty days from this date, in exer-cise of the powers conferred on him by Sec-tions 3 and 10 of the Road Haulage Wages Act, 1938, and the Second Schedule thereto and by the said Section 10 as modified and applied to and for the purposes of the Holidays with Pay Act, 1938, by the Holidays with Pay (Adaptation of Enactments) (Trade Boards and Road Haulage) Regulations, 1938, and by Section 3 of the Holidays with Pay Act, 1938, and of all other powers enabling him in that behalf, to make regulations to be entitled the Road Haulage (Notices) Regulations, 1939, with regard to the notice to be given of proposals of the Road Haulage Central Wages Board to fix remuneration, or to amend or cancel any road haulage wages order, or to give, cancel, vary or amend any direction under the Holidays with Pay Act, 1938, and with regard to the notice to be given of any order giving effect to any such proposals of the Road Haulage Central Wages Board, and with regard to the duty of employers to post notices for the purpose of informing persons employed by them of all such proposals and orders.
