DISEASES OF ANIMALS ACTS, 1894 TO 1937.

Notice is hereby given in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made the following Order:—

Order No. 5831.

(Dated 25th February, 1939.)

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) SPECIAL ORDER No. 32 OF 1939.

SUBJECT.

I. Declares the Area described in the First Schedule to be an Infected Area for the purpose of preventing the spread of foot-and-mouth disease to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied.

II. Provides that that part of the Infected Area around Great Chart, Kent, which is included in the Area described in the First Schedule, shall cease to form part of the former Infected Area.

III. Contracts the Foot-and-Mouth Disease Infected Area around Great Chart, Kent, as from the 2nd March, 1939, so as to comprise only the Area described in the Third Schedule.

IV. Releases the Foot-and-Mouth Disease Infected Area around Great Chart, Kent, and revokes Order No. 5826 as from the 9th March, 1939.

FIRST SCHEDULE.

An Area comprising : ____

IN THE COUNTY OF KENT.

The city and county borough of Canterbury. The boroughs of Margate, Ramsgate, Faversham, Queenborough and Sandwich.

The parish of Sarre.

The petty sessional divisions of St. Augustine, Ramsgate, Faversham and Thanet (including its detached part).

In the petty sessional division of Sittingbourne.

The parishes of Iwade, Sittingbourne and Milton, Tunstall, Milsted, Rodmersham, Kingsdown, Bapchild, Tonge, Elmley, Sheerness, Minster in Sheppey, Eastchurch, Harty, Leysdown and Warden.

In the petty sessional division of Bearsted.

The parishes of Wichling and Otterden; and so much of the parish of Lenham as lies to the North of the Ashford branch line of the Southern Railway.

In the petty sessional division of Ashford.

The parishes of Chilham, Molash, Godmersham, Crundale, Hastingleigh and Brabourne; and so much of the parishes of Charing, Westwell, Challock, Wye and Boughton-Aluph as lies to the North and North-east of the road running from Lenham via Old Shelve, Charing, Stockers Head, Paddock, Challock Lees, Rattle Hall, White Hill, Boughton Corner, Wye, Amage Farm and Cuckoldscomb to Brabourne.

In the petty sessional division of Elham.

The parishes of Stelling, Elmstead, Stowting, Monks Horton, Lyminge, Stelling Minnis, Elham and Acrise.

In the petty sessional division of Wingham.

The parishes of Stourmouth, Wickhambreux, Littlebourne, Ickham and Well, Wingham, Staple, Preston, Ash, Woodnesborough, Adisham, Goodnestone, Eastry, Worth, Northbourne, Tilmanstone, Eythorne, Coldred, Nonington, Bishopsbourne, Kingston, Barham, Womenswold, Sibertswold, Denton, Wootton, Lydden and Swingfield.

THIRD SCHEDULE.

An Area comprising: ____

IN THE COUNTY OF KENT.

In the petty sessional division of Ashford.

The parishes of Eastwell, Hinxhill, Brook, Mersham, Sevington, Ashford, Kingsnorth, Great Chart, Shadoxhurst, Bethersden, Pluckley, Little Chart and Hothfield; so much of the parishes of Charing, Westwell, Challock, Wye and Boughton Aluph as lies to the South and South-West of and including the road runand South-West of and including the foad fun-ning from Egerton via Stonebridge Green, Brockten, Coppins Corner, Stockers Head, Paddock, Challock Lees, Rattle Hall, White Hill, Boughton Corner, Wye, Amage Farm and Cuckoldscomb to Brabourne; and so much of the parishes of Bilsington, Ruckinge, Wanehorne, Orlestone, Kenardington and Woodchurch as lies to the North and East of the road running from Lympne via Bilsington, Herne House, Ruckinge Church, Ham Street, The Leacon, Hunt's Wood, Woodchurch Church, Shirkoak and Jarvis' Farm to High Halden.
