The Civil Service Commissioners hereby give notice of a competition (written examination followed by Selection Board) to be held under the Regulations dated the 2nd September, 1938, and published in the London Gazette of the same date, for the appointment of Male Assistant Surveyors in the Directorate of Works of the Air Ministry. It is anticipated that at least six vacancies may be available to be filled on the result of this competition, if the necessary candidates should be recommended by the Selection Board. The written examination will be held in London, commencing on the 23rd May, 1939.
