WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94; of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94; and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared and laid before His Majesty in Council a Scheme or Representation, bearing date the 2nd day of March, 1939, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared and now humbly lay before Your Majesty in Council the following Scheme or Representation for altering the boundaries of the New Parish of Saint Peter, Aldborough Hatch, and the New Parish of Saint Paul, Goodmayes, both in the County of Essex and in the Diocese of Chelmsford:

“ Whereas by the authority of an Order of Her said late Majesty in Council bearing date the 9th day of January, 1863, and published in the London Gazette on the 13th day of the same month, a Consolidated Chapelry was assigned to the consecrated Church of Saint Peter, situate at Aldborough Hatch, in the New Parish of Trinity, Barkingside, in the said County of Essex and at that time in the Diocese of London but now in the said Diocese of Chelmsford, and such Consolidated Chapelry was named ‘ The Consolidated Chapelry of Saint Peter, Aldborough Hatch ’:

“ And whereas by the authority of an Order of His late Majesty King George the Fifth in Council bearing date the 2nd day of May, 1917, and published in the London Gazette on the 4th day of the same month, a District Chapelry was assigned to the consecrated Church of Saint Paul, Goodmayes, situate within the New Parish of Saint Chad, Chadwell Heath, in the said County of Essex and in the said Diocese of Chelmsford, and the said District Chapelry was named ‘ The District Chapelry of Saint Paul, Goodmayes ’:

“ And whereas the said Consolidated Chapelry of Saint Peter, Aldborough Hatch, and the said District Chapelry of Saint Paul, Goodmayes, have become New Parishes of the character contemplated by the Act of the 6th

and 7th years of Her said late Majesty, Chapter 37, by the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, and by the above-mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

“ And whereas it has been represented to us, and it appears to us to be expedient that the boundaries of the said New Parish of Saint Peter, Aldborough Hatch, and of the said New Parish of Saint Paul, Goodmayes, should be altered in the manner which is hereinafter mentioned:

“ Now, therefore, with the consent of the Right Reverend Henry, Bishop of Chelmsford (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Saint Peter, Aldborough Hatch, and of the said New Parish of Saint Paul, Goodmayes, shall be altered so that all that portion of the said New Parish of Saint Peter, Aldborough Hatch, which is described in the Schedule hereunder written and is delineated and set forth upon the Map or Plan hereunto annexed and is thereon coloured pink, shall be dis severed from such New Parish and shall be annexed to and shall in future form part of the said New Parish of Saint Paul, Goodmayes.

“ And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

“ THE SCHEDULE to which the foregoing Scheme or Representation has reference.

“ The territory to be dis severed from the New Parish of Saint Peter, Aldborough Hatch, in the County of Essex and in the Diocese of Chelmsford, and to be annexed to the New Parish of Saint Paul, Goodmayes, in the said County and Diocese, being:—

“ All that portion of the said New Parish of Saint Peter, Aldborough Hatch, which is bounded upon the south by the said New Parish of Saint Paul, Goodmayes, upon the east by the New Parish of Saint Chad, Chadwell Heath, in the said County and Diocese, and upon the remaining sides, that is to say, upon the north and upon the west, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Chad, Chadwell Heath, from the said New Parish of Saint Peter, Aldborough Hatch, at a point in the middle of Grove Road opposite to the eastern end of the wall which forms the southern boundary of the premises attached to the Ilford Borough Council's Isolation Hospital, and extending thence first westward to and then first westward, then northward and then again westward along the said wall for a distance of 31½ chains or thereabouts to the point where it reaches the eastern side of Barley Lane, and extending thence first westward to and then southward along the middle of Barley Lane for
