WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94; of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94; and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 16th day of March, 1939, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Saint Andrew, Earlsfield, in the County of Surrey and in the Diocese of Southwark:

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the 30th day of June, 1890, and published in the London Gazette on the following day, portions of the New Parish of Saint Mary, Summers Town, and of the Parish of Saint Anne, Wandsworth, both in the said County of Surrey and at that time in the Diocese of Rochester but now in the said Diocese of Southwark, were assigned as a Consolidated Chapelry to the consecrated Church of Saint Andrew, Earlsfield, and the said Consolidated Chapelry of Saint Andrew, Earlsfield 'The Consolidated Chapelry of Saint Andrew, Earlsfield 'Earlsfield':

"And whereas the said Consolidated Chapelry of Saint Andrew, Earlsfield, has under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become a New Parish of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37,

and by the above mentioned Act of the 32nd and 33rd years of Her said late Majesty,

Chapter 94:

"And whereas it has been represented to us, and it appears to us to be expedient that the boundaries of the said New Parish of Saint Andrew, Earlsfield, should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Reverend Richard Godfrey, Bishop of Southwark (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publica-tion in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order, the boundaries of the said New Parish of Saint Andrew, Earlsfield, shall be altered so that all that portion of the said New Parish which is described in the Schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured pink shall be dissevered from such New Parish and shall be restored to and shall in future form part of the said Parish of Saint Anne, Wandsworth.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of any of them or of any

other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be dissevered from the New Parish of Saint Andrew, Earlsfield, in the County of Surrey and in the Diocese of Southwark, and to be restored to the Parish of Saint Anne, Wandsworth, in the said County and

Diocese, being:—

"All that portion of the said New Parish of Saint Andrew, Earlsfield, which is bounded upon all sides as follows, that is to say, upon the south-west by the District of Saint John the Divine, Earlsfield, in the said County and Diocese, upon the north-west and upon the north-east by the said Parish of Saint Anne, Wandsworth, upon part of the south-east by the New Parish of Saint Mary Magdalene, Wandsworth Common, in the said County and Diocese and upon the remaining part of the south-east by the middle of the main line of the Western Section of the Southern Railway."
