WELLINGTON (SALOP) GAS.

(Application for Special Order under Gas Undertakings Acts, 1920 to 1934.)

NOTICE is hereby given that application is intended to be made to the Board of Trade by the Wellington (Salop) Gas Company (hereinafter called "the Company") whose address is Market Street, Wellington in the County of Salop for a Special Order under the Gas Undertakings Acts, 1920 to 1934, for all or some of the following purposes (that is to say):—

1. To extend the limits within which the Company are authorised to supply gas so as to include:—

In the County of Salop—

So much of the parish of Lilleshall in the rural district of Wellington as is not comprised in the existing limits;

So much of the urban district of Oaken-gates as was prior to the 1st day of April 1934 comprised in the parish of Shifnal in the rural district of Shifnal and as is not comprised in the existing limits;

So much of the parish of Shifnal in the rural district of Shifnal as lies to the west of an imaginary straight line drawn from the south-easternmost point of the parish of Lilleshall to the junction of Naird Lane with the main road from Wellington to Wolverhampton and as is not comprised in the existing limits;

(hereinafter called "the added limits") and to provide that, subject to the provisions of the intended Order, the Company shall within the added limits have and may exercise the like powers, rights, privileges and authorities and
