RATES OF INTEREST ON LOCAL LOANS.

NOTICE.

The Lords Commissioners of His Majesty's Treasury hereby give notice that in pursuance of the powers conferred on Them by the Public Works Loans Act 1897 (60 and 61 Vict. c. 51) the Public Works Loans Act 1917 (7 and 8 Geo. 5. c. 32) the Public Works Loans Act, 1918 (8 and 9 Geo. 5. c. 27), the Housing Act, 1936 (26 Geo. 5. & 1 Edw. 8. c. 51), and the Housing (Scotland) Act, 1925 (15 Geo. 5. c. 15) as amended by the Housing (Scotland) Act, 1935 (25 and 26 Geo. 5. c. 41), They have been pleased to direct by Their Minute of the 9th May, 1939, that on loans granted from the Local Loans Fund, on and after the 10th May, 1939, there shall be chargeable in lieu of the rates fixed by the Treasury Minute of the 31st March, 1939, the following rates of interest:—

I.—HOUSING LOANS.
