

WHEREAS the endowments of the benefice of Baumber with Great Sturton, in the County of Lincoln and in the Diocese of Lincoln, comprise the annual amount of Fifty pounds permanently charged on the endowments or some part or parts of the endowments of the United Benefice of Edlington with Wispington in the said County and Diocese:

And whereas we, the Ecclesiastical Commissioners for England, have been requested by the Incumbents of the said two Benefices to substitute for the said charge an annual sum of the like amount charged on our Common Fund:

Now therefore, we, the Ecclesiastical Commissioners for England, acting in pursuance of the Ecclesiastical Commissioners (Powers) Measure, 1938, Section four, do hereby, subject as hereinafter mentioned, grant out of our Common Fund to the Incumbent of the said Benefice of Baumber with Great Sturton, and to his successors Incumbents of the same Benefice, one yearly sum or stipend of Fifty pounds to be calculated as from the 1st day of May, 1939, and to be in lieu of and in full substitution for the said annual sum charged upon the revenues of the said United Benefice of Edlington with Wispington:

And we, the said Ecclesiastical Commissioners, do hereby appropriate for the benefit of our Common Fund as from the said 1st day of May, 1939, the sum of £1666 13s. 4d. Local Loans £3 per cent. per annum Stock being a part of a larger sum of the same Stock now held by us as part of the endowment of the said United Benefice of Edlington with Wispington to the intent that from and after the same date the endowments of the said United Benefice of Edlington with Wispington shall be discharged from the payment of the said annual charge of Fifty pounds.
