

therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 15th day of June, 1939, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure of Colmer with the Chapelry of Priors Dean annexed (hereinafter called ‘ the said Benefice of Colmer with Priors Dean ’) in the County of Southampton and in the Diocese of Winchester :

“ Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Colmer with Priors Dean is vested in Caroline Selina Hervey, of Grafton Lodge, West Lulworth, in the County of Dorset, Widow, and Caroline Ethel May Hervey, of Grafton Lodge aforesaid, Spinster, as executors of the Will dated the 28th day of February, 1920, of the late Alfred Cyril Hervey, of Colmer Rectory, Alton, in the said County of Southampton, Clerk in Holy Orders, and the beneficiaries under the said Will are the said Caroline Selina Hervey, the said Caroline Ethel May Hervey, Kathleen Evelyn Mildred Ann Randall, wife of Eric Charles Randall, of ‘ The White House ’ Farnborough Road, Farnborough, in the County of Hants, Winifred Edith Bertha Arrol, wife of Archibald Theodore Arrol, of South Grange, Ryton-on-Tyne, in the County of Durham, John Theodore Lamplugh Hervey, of Dunluce Sicamous, British Columbia, Canada, Esquire, and Thomas Alfred Lamplugh Hervey, of 5, Arbutus Street, Mosman, Sydney, New South Wales, a Lieutenant in Your Majesty’s Navy :

“ And whereas the said Caroline Selina Hervey and the said Caroline Ethel May Hervey, with the consents of the said Kathleen Evelyn Mildred Ann Randall, Winifred Edith Bertha Arrol, John Theodore Lamplugh Hervey and Thomas Alfred Lamplugh Hervey, are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Colmer with Priors Dean, now vested as aforesaid, should be transferred to and be vested in the Bishop of Winchester for the time being:

“ And whereas the Right Reverend Cyril Forster, now Bishop of Winchester, is willing to accept such transfer, and, in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the hereinbefore mentioned Acts or by some or one of them is made necessary, he, the said Cyril Forster, Bishop of Winchester, has executed this Scheme as hereinafter mentioned:

“ And whereas the transfer of the Patronage of the said Benefice of Colmer with Priors Dean which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Colmer with the Chapelry of Priors Dean annexed:

“ Now, therefore, with the consents of the said Caroline Selina Hervey, Caroline Ethel May Hervey, Kathleen Evelyn Mildred Ann Randall, Winifred Edith Bertha Arrol, John Theodore Lamplugh Hervey and Thomas Alfred Lamplugh Hervey (in testimony whereof they have signed and sealed this Scheme) and with the consent of the said Cyril Forster, Bishop of Winchester (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Colmer with Priors Dean, now vested as aforesaid, shall be transferred to the said Cyril Forster, Bishop of Winchester, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Cyril Forster, Bishop of Winchester, and by his successors in the same Bishopric for ever.

“ And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.”

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Winchester.

UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923.

A STATUTE made by the Governing Body of All Souls College, in the University of Oxford, on the 17th June, 1939, amending Statute IV of the College Statutes, has been submitted
