NOTICE is hereby given that the Coal Commission in pursuance of their powers under paragraph (b) of Sub-section (4) of Section 3 of the Coal Act, 1938, have given direction for the exclusion from the operation of the said paragraph of the minerals and substances hereinafter specified which are comprised in Heads of Terms dated 27th May, 1909, and made between John Vaughan Colby, of the one part and Henry Roberts (the elder), Evan Roberts, James John, John Roberts, William Roberts, Henry Roberts (the younger), Isaac Rees and Elizabeth Roberts, of the other part, (the lessees' interest in which is now vested in the Pwll Coal & Brick Co.
