DARKENING SHIP ORDER.

C. In harbours where Air Raid Precautions are in force.

In pursuance of Regulation 43 of the Defence Regulations, 1939, the Lords Commissioners of the Admiralty hereby make the following Order.

2. Subject to the foregoing limitations no light of any description shall be exposed between sunset and sunrise:—

1. This Order shall have effect:—

A. In Areas for which Route Instructions are issued and on Routes where a Convoy system is in force, and

(a) in any British vessel (not being either a ship of war or a hospital ship or a Dominion ship) or

B. In Areas and on Routes, other than those above mentioned, whenever information is received from the Admiralty, an

(b) in any Dominion or foreign vessel (not being either a ship of war or a hospital ship) within the territorial waters of the United Kingdom;
