LAND DRAINAGE ACT, 1930.

*River Nene Catchment Board.**North Level Commissioners.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 24th July, 1939, in relation to the Scheme prepared by the River Nene Catchment Board, under Section 4 (1) (b) of the Act, providing for the making of alterations in the provisions of the North Level Acts in respect of the appointment and the proceedings of the North Level Commissioners, and for certain matters supplemental thereto.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

PUBLIC HEALTH (DRAINAGE OF TRADE PREMISES) ACT, 1937.

Byelaws with respect to the Discharge of Trade Effluents into Public Sewers.

NOTICE is hereby given that the City Council of Sheffield intend after the expiration of two months from the publication of this notice to make certain Byelaws under the provisions of the above Act with respect to the discharge of trade effluents into the public sewers of the Council.

The Byelaws will relate to all trade effluents as defined by the said Act. A trade effluent is so defined as any liquid, either with or without particles of matter in suspension therein, which is wholly or in part produced in the course of any trade or industry carried on at trade premises, and, in relation to any trade premises, means any such liquid as aforesaid which is so produced in the course of any trade or industry carried on at those premises, but does not include domestic sewage. Trade premises are defined as any premises used or intended to be used for carrying on any trade or industry.
