RULES PUBLICATION ACT, 1893.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon him by Section 10 of the London Traffic Act, 1924, to make the London Traffic (Prescribed Routes) (No.) (Camden Road, St. Pancras) Regulations, 1939, in regard to a scheme of one-way traffic working at the junction of Great College Street and Camden Road, St. Pancras.

SEA-FISHING INDUSTRY ACTS,
1933 AND 1938.

The following Order under the Sea-Fishing Industry Acts, 1933 and 1938, has been made by the Minister of Agriculture and Fisheries and the Secretary of State for Scotland:

The Sea-Fish Industry (Immature Sea-Fish) Revocation Order, 1939.

This Order revokes, as from the date of the Order, the Sea-Fish Industry (Immature Sea-Fish) Order, 1938, which provided that no person in Great Britain should land, sell, expose or offer for sale, or have in his possession for the purpose of sale any sea-fish of specified descriptions of less than the specified sizes.
