## FOOT-AND-MOUTH DISEASE (INFECTED AREAS) SPECIAL ORDER No. 56 OF 1939.

Declares the Area described in the Schedule to be an Infected Area for the purpose of preventing the spread of foot-and-mouth disease

to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied.
