IMPORTATION OF CANADIAN CATTLE (AMENDMENT) ORDER OF 1939.

Amends Article 3 (e) of the Importation of Canadian Cattle Order of 1933, in regard to the tags used for marking Canadian cattle imported into Great Britain.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) SPECIAL ORDER No. 60 OF 1939.

SUBJECT.

I. Contracts the Foot-and-Mouth Disease Infected Area around Colehill, Dorset and Donhead St. Mary, Wilts, so as to comprise two separate areas each approximately five miles radius round the Infected Places, and revokes Order No. 5886, as from the 24th November, 1939. These areas include parts of the counties of Dorset and Wiltshire.

II. Releases the Infected Area around Colehill, Dorset, from restrictions as from the 28th November, 1939.

III. Releases the Infected Area around Donhead St. Mary, Wilts, from restrictions as from the 1st December, 1939.

LAND DRAINAGE ACT, 1930.

*River Roding Catchment Board.**Internal Drainage Districts Scheme, 1939.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 12th October, 1939, in relation to the Scheme prepared by the River Roding Catchment Board, under Section 4 (1) (b) of the Act, making provision for the abolition of the Ilford Bridge to Ongar and Canfield Internal Drainage District, and for the constitution of the Ilford Bridge to Loughton Internal Drainage District, the Abridge to Hallsford Bridge Internal Drainage District and the Chipping Ongar to Canfield Internal Drainage District.

A copy of the Order may be seen at all reasonable hours at the office of the Clerk of the Catchment Board, National Provincial Bank Chambers, Romford, Essex, and also at the offices of the Ministry of Agriculture and Fisheries, 10, Whitehall Place, London, S.W.1.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
