## NORWICH.

Whereas the Lord Mayor, Aldermen, and Citizens of the City of Norwich (hereinafter called the Corporation) have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Norwich Corporation Act, 1920, and the Norwich Order, 1935, so as:—

(1) To extend the limits within which the Corporation may supply water by the inclusion within those limits of the following areas, all of which are in the County of Norfolk:—

(a) the parishes of Belaugh, Brampton, Buxton with Lamas, Coltishall, Crostwick, Frettenham, Horstead with Stanninghall, Salhouse, Taverham, Tuttington, Wroxham in the rural district of St. Faith's and Aylsham,

(b) the parishes of Ashmanhaugh, Horning, Hoveton, Neatishead, Scottow, Sloley, Smallburgh, Tunstead in the rural district of Smallburgh,

(c) the parishes of Bramerton, Caistor, St. Edmunds (excluding that part which prior to the operation of the County of Norfolk Review Order, 1935, comprised the parish of Marshall), Easton, East Carlton, Framingham Earl, Framingham Pigot, Great Melton, Holverston, Ketteringham, Mulbarton, Poringland, Rockland St. Mary, Stoke Holy Cross, Surlingham, Swainsthorpe, Swardeston in the rural district of Forehoe and Henstead.

(2) To empower the Corporation to charge for water for domestic purposes in the above parishes proposed to be included in the limits at a yearly rate not exceeding ten per centum upon the gross value of the premises supplied.

(3) To empower the Corporation to acquire by agreement the waterworks constructed to supply the Kett's Oak Estate in the parish of Hethersett in the rural district of Forehoe and Henstead.

(4) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said City as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is hereby given that the Minister of Health will consider any objections or representations made in writing before the nineteenth day of December by any person or body interested in the subject matter of the said Application and the proposed Provisional Order. Such objections or representations should be addressed to the Secretary, Ministry of Health, Whitehall, London, S.W.1, and copies of them should be sent at the same time to the Town Clerk, City Hall, Norwich.
