"And whereas the improvement in the annual value of the said Benefice arising from or by means of the said sales and leases exceeds the annual sum of f_{800} , and after the appropriation hereinafter recommended to us, the said Ecclesiastical Commissioners, for the benefit of our Common Fund, the average annual income of the said Benefice will still be in excess of f_{600} :

"And whereas the said Benefice of Enfield is now vacant:

"Now, therefore, we, the said Ecclesiastical Commissioners, humbly recommend and propose that as from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme (first) the said sum of $f_{2,000}$ Local Loans f_{3} per centum per annum Stock, the said sum of $f_{3,429}$ IS. 8d. f_{3} IOS. per centum per annum Conversion Stock, a sum of $f_{I,333}$ 6s. 8d. India f_{3} per centum per annum Stock (being a portion of the aforesaid sum of the same Stock) and a sum of $f_{6,666}$ I3S. 4d. f_{3} per centum per annum Redemption Stock (being a portion of the aforesaid sum of the same Stock) shall cease to be held by us for the benefit of the Vicar or Incumbent of the said Benefice of Enfield and shall be held by us for the benefit of our Common Fund to be applied as in the said Acts mentioned, and (secondly) all those the lands, tenements and hereditaments described in the said schedule hereunder written, subject to all leases, tenancies or agreements affecting the same, and with the benefits of the rents thereby reserved and the covenants and conditions therein contained, shall be transferred to us, the said Ecclesiastical Commissioners, and shall become and be absolutely vested in us for the benefit of our Common Fund to be applied as in the said Acts mentioned.

"And we further recommend and propose that nothing herein contained shall prevent us from making any other recommendations and proposals relating to the matters aforesaid, or any of them in accordance with the provisions of the said Acts or Measure or of any of them or of any other Act of Parliament or of any other Measure of the National Assembly of the Church of England.
