And whereas in pursuance of the powers vested in Us by the said Acts We did, by Warrant under Our Royal Sign Manual bearing date the first day of January, one thousand nine hundred and thirty-seven, appoint you Our said Most Dear Uncle and Counsellor Arthur William Patrick Albert, Duke of Connaught and Strathearn, together with the persons therein named to be members of the Royal Patriotic Fund Corporation until the thirty-first day of December, one thousand nine hundred and thirty-nine:

Now know ye that We do by these Presents under Our Royal Sign Manual ordain and declare that you Our said Most Dear Uncle and Counsellor Arthur William Patrick Albert, Duke of Connaught and Strathearn, together with you the said Sir Frederick Spencer Robb, Sir Hugh Dudley Richards Watson, Sir Herbert Ernest Fass, Sir Henry John Studholme Brownrigg, William Sanger, Elizabeth Hariott Kelly and Guy William Lambert, shall be Members of the Royal Patriotic Fund Corporation, to exercise for the term of three years from the first day of January, one thousand nine hundred and forty, in conjunction with the six members co-opted by the General Council, and the ex-officio members specified in the First Schedule to the Act first above recited, the powers and duties transferred to that body as aforesaid, and generally to carry into effect the provisions of the said Act:

And We do further ordain that you Our said Most Dear Uncle and Counsellor Arthur William Duke of Connaught Patrick Albert, and Strathearn, shall be President of the General Council of the said Corporation.
