NATIONAL HEALTH INSURANCE ACTS, 1936 TO 1939.

NATIONAL HEALTH INSURANCE ACTS (NORTHERN IRELAND) 1936 TO 1939.

Notice is hereby given under the Rules Publication Act, 1893 that it is proposed by the National Health Insurance Joint Committee, the Minister of Health and the Ministry of Labour for Northern Ireland, acting jointly, after the expiration of at least forty days from this date, in pursuance of the powers conferred on them by the National Health Insurance Acts, 1936 to 1939, and the National Health Insurance Acts (Northern Ireland), 1936 to 1939 and of all other powers enabling them in that behalf and subject to the approval of the Treasury and the Ministry of Finance for Northern Ireland to make regulations to be entitled the National Health Insurance (Navy, Army and Air Force) Amendment Regulations 1940:
