Chichester, and such certified copies of the said Maps will be open for inspection by all persons interested, without charge, between the hours of 9.30 a.m. and 4.30 p.m. on weekdays, except on Saturdays when the hours will be from 9.30 a.m. to 12.30 p.m. (3) Any person who is, or claims to be, the owner of any property in the above areas, and any association representing owners of property within the Horsham or Chichester Rural District, as the case may be, and any local association representing business or industry, may by notice in writing, specifying in the case of an owner the property to which he claims to be the owner, require the West Sussex County Council to register without charge his or their name and address for the service of subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933, the development of land in the areas during the preparation of the scheme is permitted to the extent specified in the Order and in addition the Horsham Rural District Council as respects the area in the Parish of Billingshurst and the Chichester Rural District Council as respects the areas in the Parishes of North Mundham and Sidlesham are empowered to permit other development in such areas during this period, with a view in either case to protecting the development from the risk of removal or alteration without compensation under the scheme when approved and in operation. A print of the Order has been deposited together with each of the deposited Maps.

NEWHAVEN (SUSSEX): PROPOSED PROHIBITION OF REMOVAL, ETC., OF MATERIALS FROM THE SEASHORE.
