Whitehall, February 17, 1940.

His Majesty The KING has been graciously pleased to award the King's Police Medal for gallantry to Donald Gainsford, Esq., Senior Superintendent of Police, Alexander Adam Mackeith, Esq., Assistant Superintendent of Police, and the late Foot Constable Abdul Rehman of the Lahore District Police, in recognition of their gallantry on the 8th October, 1939, in an encounter with an armed military deserter. The officers displayed complete disregard for their personal safety, and the Foot Constable was fatally shot before the deserter was himself brought down.

AIR-RAID PRECAUTIONS ACT, 1937.

Notice is hereby given under the Rules Publication Act, 1893, that the Minister of Home Security proposes, after the expiration of at least forty days from this date, in exercise of the powers conferred on him by the Air-Raid Precautions Act, 1937, and of all other powers enabling him in that behalf, to make an Order to be entitled the Air-Raid Precautions (London) (Allocation of Duties) Order, 1940.
