"And whereas it has been proposed to us that the patronage of the said two Benefices should be assigned and transferred by way of exchange in the manner which is hereinafter recommended and proposed:

"And whereas we have made due inquiry and calculation as to the circumstances and relative value of the said two Benefices and of the patronage thereof respectively and we do hereby certify to Your Majesty in Council that the circumstances and present values of the said two Benefices are as set forth in the Schedule hereunto annexed:

"Now, therefore, with the consent of the Walker Hobart, Thomas Viscount Caldecote, Lord High Chancellor of Great Britain, acting on behalf of Your Majesty (in testimony whereof he has signed and sealed this Scheme) and with the consent of the said Dean and Chapter of the Cathedral Church of Saint Peter at Exeter (in testimony whereof they have caused their Common or Capitular Seal to be affixed to this Scheme) we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted order the whole advowson or perpetual right of patronage of and presentation to the said Benefice of Pilton shall be transferred from the said Dean and Chapter and from their successors and shall thereupon and thenceforth belong to Your Majesty, Your Heirs and Successors, to the intent that the same shall from time to time and at all times be exercised on Your Majesty's behalf by the Lord High Chancellor of Great Britain and that in exchange for the same the share of the patronage of and presentation to the said Benefice of Saint Olave with All Hallows on the Wall, Exeter, which is now, as aforesaid, exercised upon Your Majesty's behalf by the Lord High Chancellor of Great Britain shall in like manner and upon and from the same date be assigned and transferred from Your Majesty, Your Heirs and Successors and shall thereupon and thenceforth belong to the said Dean and Chapter to the intent that the whole right of patronage of and presentation to the said Benefice of Saint Olave with All Hallows on the Wall, Exeter, may from time to time and at all times be exercised by the said Dean and Chapter and their successors.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament.

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Exeter.
