the Public Health, the opening of any new burial ground in the Civil Parish of Elham, in the County of Kent, save with the previous approval of the Minister of Health, should be prohibited, and that burials should be discontinued therein as hereinafter directed:

And whereas by an Order in Council of the 22nd February, 1940, Notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 4th day of April next, and such Order has been published in the London Gazette, and copies thereof have been affixed, as required by the said Act:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, as it is hereby ordered, that no new burial ground shall be opened in the said Civil Parish of Elham save with the previous approval of the Minister of Health, and that burials shall be discontinued therein as follows, viz. :-

Elham.-Forthwith and entirely in the Church of Saint Mary Virgin, in the said Parish, and in the Churchyard attached thereto.

Provided that-

(a) In any vault or walled grave now existing in the said Churchyard burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented.

b) In any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the con-dition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.
