and machine gun fire, and containing both ammunition and an enemy bomb which had not exploded, was lying, on fire, on the beach at Covehithe.

After two unsuccessful attempts had been made to get on board, Private Storey volun-

teered to make a further effort.

Undeterred by the danger, and with the intention of succouring any possible survivors, he climbed up the side of the ship on two ladders lashed together. Thirty-five feet up, one of the ladders broke, but he managed to clutch a block of davit falls, and was hauled up to deck level, by means of a loose rope.

Private Storey then ran through the fire, entered the magazine, which was in danger of being reached by the fire at any moment, searched and found a rope ladder, and then, again braving the flames, lowered the ladder

over the side.

By this time the remainder of the party

were able to get on board.

Private Storey, a young soldier of 18 months' service, rendered outstanding services, in spite of the imminent danger in which he was placed, with coolness and determination.
