Now therefore, in pursuance of the powers conferred on me by Regulation 7 of the Dangerous Drugs Regulations, 1937, and by Regulation 5 of the Raw Opium etc. Regulations, 1937, I hereby withdraw from the said Graham Campbell MacDiarmid, the authorities conferred by the said Regulations upon him to be in possession of and to supply the drugs or preparations to which the Dangerous Drugs Regulations, 1937, and the drugs to which the Raw Opium etc. Regulations, 1937, apply:

And I hereby direct that it shall not be lawful for the said Graham Campbell MacDiarmid to give prescriptions for the purposes of the Dangerous Drugs Regulations, 1937...
