## SHIPLEY.

Whereas it is provided by Section 25 (Intersecting streets) of the Shipley Urban District Council Act, 1912 (hereinafter referred to as "the local Act"), that no street shall be laid out of more than one hundred and thirty yards in length without an intersecting street at intervals of not more than one hundred and thirty yards in any such street, and that any person who shall offend against this section shall be liable to a penalty not exceeding five pounds and to a daily penalty not exceeding forty shillings.
