EMERGENCY POWERS (DEFENCE).

ROAD TRAFFIC.

The Minister of Transport hereby gives notice that in pursuance of the powers conferred upon him under Regulation 70 of the Defence (General) Regulations, 1939, he has made The Regulation of Traffic (Samlesbury) Order, 1940. The Order provides that no person shall cause or permit any vehicle to wait in that length of the Liverpool-Preston-Leeds-Hull Trunk Road (A.677) between a point 50 yards west of its junction with Intack Lane, Samlesbury, and a point 1,407 yards west of that junction.

THE REGULATION OF TRAFFIC.

The City of Westminster (Parking Place) Order, 1940.

ROAD TRAFFIC.

The Minister of Transport hereby gives notice that in pursuance of the powers conferred upon him under Regulation 70 of the Defence (General) Regulations, 1939, he has made the Regulation of Traffic (Norwich) (No. 2) Order, 1940. The Order provides that no person during the period between sunset and sunrise shall cause or permit any vehicle to wait in the following roads in Norwich:—

St. Giles' Street, Bethel Street, Willow Lane, St. Peter Street, Hay Hill, Westlegate, Haymarket, White Lion Street, The Walk,
