

his signing this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

" 1. That the said Benefice of Eyton and the said Benefice of Lucton shall be permanently united together and form one Benefice with Cure of Souls under the style of ' The United Benefice of Lucton with Eyton ' but the Parishes of the said Benefices shall continue in all respects distinct.

" 2. That if upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette both of the said two Benefices shall be vacant the union of the same two Benefices shall take effect forthwith: and if one only of the said two Benefices shall be then vacant the said union shall take effect upon the next avoidance of the other of the said two Benefices: and if neither of the said two Benefices be then vacant the said union shall take effect upon the next avoidance of that one of the said two Benefices which shall last be avoided after the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme.

" 3. That upon the said union taking effect the Parsonage House at present belonging to the said Benefice of Lucton shall become and be the house of residence for the Incumbent of the United Benefice.

" 4. That, with the consents of the Reverend George Henzell Jobling, being the present Incumbent of the Benefice of Kingsland, in the said Diocese of Hereford (in testimony whereof he has signed this Scheme) and of the Governors of Lucton Pierrepont's School, being the Patrons of the said Benefice of Kingsland, namely, Robert Henry Evans, a Captain in Your Majesty's Army, of The Old Hall, Eyton, Leominster, in the County of Hereford, James John Stedman Powell, Esquire, J.P., of Hall Court, Marsh Marcle, Ledbury, in the said County of Hereford, Norman Birley, Esquire, of The Merchant Taylors' School, Sandy Lodge, Northwood, in the County of Middlesex, Edward Marten Dunne, D.L., a Lieutenant-Colonel in Your Majesty's Army, of Gatley Park, Kingsland, Leominster, aforesaid, Joseph Coates, O.B.E., V.D., a Lieutenant-Colonel in Your Majesty's Army, of Eyton House, Leominster, aforesaid, David Watkin Hamlen-Williams, a Captain in Your Majesty's Army, of Angel House, Kingsland, Leominster, aforesaid, Ian Stewart, C.M.G., D.S.O., a Brigadier-General, retired, of Your Majesty's Army, of Eyton Hall, Leominster, aforesaid, the Reverend William Graham Moeran, of The Vicarage, Leominster, aforesaid, Edwin Charles Grosvenor, Esquire, of Comberton, Orleton, Ludlow, in the County of Salop, Edward Thomas Cave, Esquire, of The Wharf, Leominster, aforesaid, Thomas James Nott, Esquire, J.P., of Walford, Bucknell, in the County of Salop, Robert James Bridgford, C.B., C.M.G., D.S.O., a Brigadier-General, retired, of Your Majesty's Army, of Starnbach House, Staunton-on-Arrow, Pembridge, Leominster, aforesaid, John Murdoch, Esquire, of Primrose Bank, Holme Lacey, in the said County of Hereford, Hubert Inglesby, a Captain in Your Majesty's Army, of Rosedale Court, Pudleston, Leominster, aforesaid, the Reverend George Henzell Jobling, aforesaid, and the Reverend Campbell Blethyn Hulton, of Charterhouse, in the City of London (in testimony whereof fifteen being the major part

in number of the said Governors have signed this Scheme) and with the consents also of the Reverend Reginald Arthur Leathley, being the present Incumbent of the Benefice of Eye in the said Diocese of Hereford (in testimony whereof he has signed this Scheme) and of the Right Honourable Thomas Walker Hobart, Viscount Caldecote, and of the Right Honourable John, Viscount Simon, now Lord High Chancellor of Great Britain, acting on behalf of Your Majesty as Patron of the said Benefice of Eye (in testimony whereof he has signed this Scheme) upon the said union taking effect (a) there shall be severed from the Parish of the said Benefice of Kingsland and annexed for all ecclesiastical purposes to the Parish of Eyton all that portion of the Parish of the said Benefice of Kingsland including a part of Gilbert's Farm which portion is shown upon the map or plan annexed to this Scheme and is thereon coloured green, and (b) there shall be severed from the Parish of the said Benefice of Eye and annexed for all ecclesiastical purposes to the said Parish of Eyton all that portion of the Parish of the said Benefice of Eye including the areas known as The Piddle, Lyddiatts and Scatterbrain, which portion is shown upon the said map or plan and is thereon coloured pink.

" Provided also that nothing herein contained shall prevent us from making any other recommendations and proposals relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measures, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Measures, and Notices have been transmitted to the persons or bodies entitled under the said Measures to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Measures:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Hereford has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measures.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Hereford.
