Coast Protection Act, 1939.

Newhaven, Sussex.

Whereas the Minister of Shipping is of opinion that it is desirable for the prevention of damage to the harbour works constituted by the Breakwater on the western side of Newhaven Harbour by the action of the sea that such an Order as is hereinafter mentioned should be made.

Now the Minister of Shipping in exercise of the power conferred on the Board of Trade by the Coast Protection Act, 1939, and transferred to him by virtue of the Minister of Shipping (Transfer of Functions) Order, 1939, made under the Ministers of the Crown (Emergency Appointments) Act, 1939, hereby prohibits the excavation removal or other disturbance of all materials on, under, or forming part of the seashore between a line running along the west side of the said Breakwater and continuing thence in a straight line inland in the same direction and a straight line running north and south true through Old Nore Point 200 feet

westward of the surface level marked 124 on the 1 Ordance Map 1926 revision Sussex Sheet No. LXXVIII.7 (Edition of 1928) except minerals more than 50 feet below the surface.
