east partly by the New Parish of Saint Leonard, Newark upon Trent, both in the said County and Diocese, and partly by the said Parish of Newark upon Trent, upon the south, partly by a detached portion of the Parish of East Stoke, in the said County and Diocese, partly by a detached portion of the said Parish of Newark upon Trent, and partly by another detached portion of the said Parish of East Stoke and upon the remaining side, that is to say, upon the west, by an imaginary line commencing upon the boundary which divides the last mentioned detached portion of the said Parish of East Stoke from the said Parish of Averham at a point in the middle of Old Trent Dyke, opposite to the southern end of the fence which divides the close numbered 236 upon the Ordnance Survey maps of the Civil Parish of Averham published in the year 1919 upon the scale of 25 inches to a mile and also upon the map or plan annexed to this Scheme from the close numbered 238 upon the same maps and extending northward to and along the said fence for a distance of  $9\frac{1}{2}$  chains or thereabouts to the point where it meets the southern side of the road leading from Southwell to Newark upon Trent, and extending thence north-westward diagonally across such road (thereby crossing the boundary which divides the said Parish of Averham from the said Parish of Kelham) for a distance of 13 yards or thereabouts to a point opposite the middle of the stream flowing between the closes numbered 262 and 263 on the Ordnance Survey map of the Civil Parish of Kelham published in the year 1919 upon the scale of 25 inches to a mile and also upon the map or plan annexed to this Scheme or Representation, and extending thus first northward and then north-eastward along the middle of the said stream for a distance of 34 chains or thereabouts to a point opposite the fence forming the boundary between the close numbered 238 and the close numbered 239 upon the last mentioned maps, and extending thence northward along such fence for a distance of II chains or thereabouts to the point where it reaches the southern side of the roadway forming the close numbered 231 upon the same maps, and extending thence north-westward to and along the middle of such roadway to a point opposite to the middle of the stream flowing towards Crankley Lane, and extending thence first northward and then north-eastward along the middle of such stream for a distance of 38 chains or thereabouts to the point where it meets the southern side of Crankley Lane upon the boundary which divides the said Parish of Kelham from the said Parish of South Muskham.

'II. And also all those contiguous detached portions of the said Parish of East Stoke and of the Parish of Farndon, in the said County and Diocese, which are bounded upon all sides as follows, that is to say, upon the north partly by the above described portion of the said Parish of Kelham, partly by a part of the above described portion of the said Parish of Averham, partly by the above-mentioned detached portion of the said Parish of Newark upon Trent and partly by a further part of the above described portion of the said Parish of Averham upon the west and the south-west by the said Parish of Averham and upon the southeast and the east by the middle of the River

Trent.

"The Second Schedule.

"The territory to be annexed to the said New Parish of Christ Church, Newark on

Trent comprising:

"All those contiguous portions of the said Parish of Newark upon Trent, and of the Parish of Hawton and the Parish of Balderton, both in the said County and Diocese, which, taken together, are bounded upon the west by the said Parish of Farndon, upon the north partly by the said New Parish of Christ Church, Newark upon Trent, and upon the remaining sides, that is to say, upon the remaining part of the north, upon the east, upon the south and upon the south-west, by an imaginary line commencing upon the boundary which divides the said New Parish of Christ Church, Newark upon Trent, from the said Parish of Newark upon Trent at the junction of Boundary Road with Bowbridge Road, and extending thence southward along the middle of Bowbridge Road for a distance of 2 chains or thereabouts to a point opposite to the fence forming the northern boundary of the close numbered 364 upon the Ordnance Survey map of the Civil Parish of Newark upon Trent published in the year 1920 upon the scale of 25 inches to a mile and also upon the map or plan annexed to this Scheme and extending thence eastward to and along the said fence for a distance of 15 chains or thereabouts to the point where it reaches the wall forming the western boundary of Newark Cemetery, and extending thence southward along the said wall for a distance of 17 chains or thereabouts to its southern end upon the boundary which divides the said Parish of Newark upon Trent from the said Parish of Balderton and extending thence north-eastward along such boundary for a distance of 20 chains or thereabouts to the point where it crosses the middle of the Newark and Bottesford line of the London and North Eastern Railway, and extending thence southward along the middle of the said line of railway for a distance of 42 chains or thereabouts to the centre of the bridge which carries Hawton Lane across such line of railway, and extending thence westward along the middle of Hawton Lane for a distance of 27 chains or thereabouts to the point where it meets the eastern side of Bowbridge Lane upon the boundary which divides the said Parish of Balderton from the said Parish of Hawton, and extending thence diagonally across Bowbridge. Lane for a distance of 1½ chains or thereabouts to a point in the middle of the eastern end of the roadway leading past the northern side of Hawton House into Hawton Road, and extending thence westward along the middle of such roadway for a distance of 29 chains or thereabouts to the point where it crosses the middle of the tramway running towards the Hawton Mills and the River Trent, and extending thence first northward and then north-westward along the middle of the said tramway for a distance of 60 chains or thereabouts to the point where it crosses the middle of Hawton Road, and extending thence south-westward along the middle of Hawton Road for a distance of 2 chains or thereabouts to the point opposite to the eastern end of the fence forming the southern boundary of the close numbered 19 upon the Ordnance Survey map of the Civil Parish of Hawton published in the year 1920 upon the scale of 25 inches to a mile and also upon the map or plan annexed to this
