DANGEROUS DRUGS ACTS, 1920 TO 1932.
CANCELLATION OF SUSPENSION OF WITHDRAWAL
OF AUTHORITIES.

(JOHN ALEXANDER ROSS.)

Whereas in pursuance of the powers conferred upon the Secretary of State by Regulation 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by Regulation 7 of the Dangerous Drugs (Consolidation) Regulations, 1928, the authorities granted by the aforesaid Regulations to duly qualified medical practitioners to be in possession of and to supply raw opium, coca leaves and Indian hemp, and the drugs and preparations to which Part III of the Dangerous Drugs Act, 1920, applies, were, by Notice published in the London Gazette and Edinburgh Gazette on the 30th April, 1935, withdrawn from John Alexander Ross, M.B., Ch.B. (Aberdeen), now residing at 37, Union Street, Wick, Caithness-shire (whose registered address is Fernlea, Brora, Sutherland), who had been convicted of an offence against the Dangerous Drugs Acts:

And whereas by the said Notice it was directed that it should not be lawful for the said John Alexander Ross to give prescriptions for the purposes of the Dangerous Drugs (Consolidation) Regulations, 1928:

And whereas the operation of the said Notice was by Notice published in the London Gazette and Edinburgh Gazette on the 16th February, 1937, suspended until further Order:

And whereas I am of opinion that the said John Alexander Ross cannot properly be allowed for the purposes of the Raw Opium, etc. Regulations, 1937, and the Dangerous Drugs Regulations, 1937, to remain an authorised person or to give prescriptions:

Now therefore, I hereby cancel, as from to-day's date, the Notice of suspension published in the London Gazette and Edinburgh Gazette on the 16th February, 1937.
