And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the Diocese of Manchester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94; of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94; and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94; duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 12th day of December, 1940, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared and now humbly lay before your Majesty in Council the following Scheme or Representation for altering the boundaries of the New Parish of Saint George, Sowerby, and of the New Parish of Saint Peter, Sowerby, both in the County of York and in the Diocese of Wakefield:

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the 10th day of December, 1842, and published in the London Gazette on the 14th day of March, 1843, certain parts of the Parish of Halifax, in the County of York, and at that time in the Diocese of Ripon, but now in the said Diocese of Wakefield, were assigned as Chapelry Districts to five consecrated Churches situate in the said Parish of Halifax and one of such Chapelry Districts was named 'The Chapelry District of Saint George, Sowerby':

"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the 21st day of March, 1890, and published in the London Gazette on the 25th day of the same month, a District Chapelry was assigned to the consecrated Church of Saint

Peter, Sowerby, situate in the said Parish of Halifax, and the said District Chapelry was named 'The District Chapelry of Saint Peter, Sowerby':

"And whereas the said Chapelry District of Saint George, Sowerby, and the said District Chapelry of Saint Peter, Sowerby, have under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become New Parishes of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Parishes of Saint George, Sowerby, and Saint Peter, Sowerby, should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Reverend Campbell, Bishop of Wakefield (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parishes shall be altered so that (first) all that portion of the said New Parish of Saint George, Sowerby, which is described in the First Schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured pink shall be dissevered from such New Parish and shall be annexed to and shall in future form part of the said New Parish of Saint Peter, Sowerby; and (secondly) all that portion of the said New Parish of Saint Peter, Sowerby, which is described in the Second Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured green shall be dissevered from such New Parish and shall in future form part of the said New Parish of Saint George, Sowerby.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measure relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or any of them or of any other Act of Parliament.

"THE SCHEDULES to which the foregoing Scheme or Representation has reference.

"THE FIRST SCHEDULE.

"The territory to be dissevered from the New Parish of Saint George, Sowerby, in the County of York and in the Diocese of Wakefield, and to be annexed to the New Parish of Saint Peter, Sowerby, in the same County and Diocese, being:—

"All that portion of the said New Parish of Saint George, Sowerby, which is bounded upon the west and upon a part of the north by the said New Parish of Saint Peter, Sowerby, and upon the remaining sides, that is to say, upon
