#### FINANCE ACT, 1940.

Notice is hereby given that the Minister of Transport in pursuance of the power conferred on him by Section 8 of the Finance Act, 1940, has made the Road Vehicles Licensing (Leave Permit) Regulations, 1941, which with retrospective effect as from the 19th April, 1940, lays down the conditions under which permits to use unlicensed motor cars and motor cycles are granted to members of His Majesty's Naval, Military and Air Forces on short leave from service afloat or overseas.

Contracts the Foot-and-Mouth Disease Infected Area around Dymchurch, Kent, as from 19th January, 1941, to an area comprising the districts situate within approximately 5 miles around Dymchurch and, on 26th January, 1941, releases the contracted area from restrictions and revokes Order No. 6019.

I.
