Under the Special Enactments (Extension of Time) Act, 1940, the Electricity Commissioners have made an Order entitled the New Sarum Electricity (Extension of Purchase Date) Order, 1941, extending for one year the period ending on 6th July, 1940, within six months after the expiration of which the Corporation of New Sarum may, by virtue of Section 3 of the New Sarum Electricity (Amendment) Special Order, 1937, exercise the right conferred on them by Section 2 of the Electric Lighting Act, 1888, to purchase the electricity undertaking authorised by the Salisbury Electric Lighting Order, 1895. Copies of the Order may be obtained from the Electricity Commission, Savoy Court, Strand, London, W.C.2.

Under the Special Enactments (Extension of Time) Act, 1940, the Electricity Commissioners have made an Order entitled the Pontefract (Extension of Purchase Date) Order, 1941, extending for three years the period of 27 years within six months after the expiration of which the Pontefract Corporation may exercise their right of requisition of the Electricity Undertaking authorised by the Pontefract Corporation Orders, 1907 and 1912.
