#### NATIONAL HEALTH INSURANCE ACT, 1936.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Health, after the expiration of at least forty days from this date, in pursuance of the powers conferred by the National Health Insurance Act, 1936, and of every other power enabling him in that behalf, to make regulations to be entitled the National Health Insurance (Seamen's Medical Benefit) Amendment Regulations, 1941;

And that, on account of urgency, the Minister of Health under section 2 of the Rules Publication Act, 1893, has made the said regulations to come into operation forthwith as provisional rules to continue in force only until regulations have been made in accordance with the provisions of section 1 of that Act.
