SOUTHEND-ON-SEA CORPORATION (TROLLEY VEHICLES) ORDER CONFIRMATION ACT, 1934.

Application for extension of time for construction of a route.

NOTICE is hereby given that the Corporation of the said Borough intend to apply to the Minister of Transport under the provisions of the Southend-on-Sea Corporation (Trolley Vehicles) Order, 1934, confirmed by the above-named Act for an Order extending by a further
