## EBBW VALE URBAN DISTRICT COUNCIL.

NOTICE is hereby given that application has been made to Parliament in the present Session by the Urban District Council of Ebbw Vale for an Act under the above name or short title the full title of which is "A Bill to empower the Urban District Council of Ebbw Vale to construct new waterworks, to confer further powers on the Council in regard to their water undertaking, and for other purposes."
