other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

And whereas by Order in Council bearing date the 22nd January, 1920, sanction was given, inter alia, to the revised rates of Command Money for Officers in command of Your Majesty's ships and shore establishments and to authorize the payment of Entertaining Allowance to Officers appointed in Command:

"And whereas by Orders in Council bearing dates the 9th April, 1932, and 26th February, 1934, sanction was also given to the payment to the Engineer Captains appointed in Command of the Mechanical Training Establishment at Chatham, and the Royal Naval Engineering College at Keyham of Command Money and Entertaining Allowance at the rates of 7s. and 5s. a day respectively:

"And whereas we consider that the Captains (E) appointed in Command of the Royal Naval Air Station, Lympne, and the Mechanical Training Establishment, Rosyth,

should be similarly remunerated.
"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to authorize payment to these officers of Command Money and Entertaining Allowance at the daily rates of 7s. and 5s. respectively, with effect from the date of taking up their appointments.
"The Lords Commissioners

of Your Majesty's Treasury have signified their concur-

rence in this proposal."

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in

"And whereas by Order in Council bearing date the 9th day of November, 1920, provision was made for the payment of Command Money to Lieutenant-Colonels or Majors of the Royal Marines placed in independent command of Royal Marine Battalions detached from their

Divisions and Depot:

"And whereas by Order in Council bearing date the 27th day of October, 1930, payment of Command Money was authorised at the rates approved from time to time for Lieutenant-Colonels and Majors, R.M., commanding Royal Marine Battalions, to Officers of those ranks when placed in command of other independent units, which, though not organized in the form of a Battalion, approach the strength of a Battalion and entail responsibilities analogous to those involved in the Command of a Battalion:

And whereas by Order in Council bearing date the 27th day of October, 1936, the rate of payment of Command Money for Lieutenant-Colonels commanding R.M. Battalions or analogous units, was increased to 7s., the rate of Entertaining Allowance being payable at our

discretion:

'And whereas we consider that Colonels, R.M., commanding Royal Marine Battalions or other analogous units should receive Command Money and Entertaining Allowance at the rates already approved for Lieutenant-Colonels, R.M., in similar circumstances:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to authorise, with effect from 7th May, 1940, the payment of Command Money and Entertaining Allowance at the rates of 7s. and 5s. respectively to Colonels, Royal Marines, subject to the conditions laid down for Lieutenant-Colonels, Royal Marines.
