And whereas at the same time a direction was given by the Secretary of State that it should not be lawful for the said Henry Scott Buckland to give prescriptions for the purposes of the Dangerous Drugs (Consolidation) Regulations, 1928.

Now, therefore, I hereby suspend, until further Order, the operation of the said Notice of Withdrawal and of the said direction regarding prescriptions.
