Office of the High Commissioner for India.

The Secretary of State for India has appointed Mr. Leonard Sidney Hollands a Deputy Superintendent in the Mercantile Marine Office, Tilbury, to superintend the transfer of lascars or other persons, and to grant the certificate required under section 125 of the Merchant Shipping Act, 1894 (57 and 58 Vic. cap. 60).

The fee to be paid for every lascar, or other person, in respect of whom such certificate is applied for, is limited to three shillings and in no case is the total amount of fees in respect of one crew to exceed five pounds.

SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT, 1940.

Whereas the County Council of the Administrative County of Middlesex (hereinafter called the Council) have made application to the Minister of Health for the issue of an Order

under the Special Enactments (Extension of Time) Act, 1940:—

(1) To extend to the 1st October, 1944, the period limited by section 26 of the Middlesex County Council (Sewerage) Act, 1938, for the compulsory purchase of the lands shown on the deposited plans or of easements which the Council by the said local act are authorised to acquire but have not yet acquired;

(2) For the several purposes of the application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said local act, or of any other local act or of any act confirming an order and in force in the said County as may be necessary or desirable:

And whereas it is proposed that an order should be issued in compliance with the said application;

Notice is hereby given that the Minister of Health will consider any objections or representations made in writing before the fifth day of June, 1941, by any person or body interested in the subject matter of the said application and the proposed order. Such objections or representations should be addressed to the Secretary, Ministry of Health, Whitehall, London, S.W.1, and copies of them should be sent at the same time to the Clerk of the County Council of Middlesex, Guildhall, Westminster, S.W.1.
