Notice is hereby given in pursuance of Section 49 (3) of the Diseases of Animals Acts, 1894, that the Minister of Agriculture and Fisheries has made the following Orders:—

Order No. 6151.

(Dated 18th June, 1941.)

Subject.

I. Revokes the Norfolk and Isle of Ely Swine Fever Infected Area (Amendment) Order of 1940 on 8th July, 1941.

II. Releases the counties of Cambridge, East and West Suffolk, and part of Essex from Swine Fever Infected Areas restrictions on 8th July, 1941.

Animals (Landing from Eire, Northern Ireland and Isle of Man) (Amendment) Order of 1941 (No. 8).

Subject.

I. Revokes the Animals (Landing from Eire, Northern Ireland and Isle of Man) (Amendment) Orders of 1941 (Nos. 5, 6 and 7) on 8th July, 1941.

II. Allows the importation at Birkenhead and Glasgow of cattle, sheep, goats or swine from Northern Ireland, and via Dublin from that part of Eire situate north and west of a line drawn from Dublin along the Grand Canal to Shannon Harbour and thence along the River Shannon to its mouth. Animals must be slaughtered at the landing place within 96 hours of landing.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 31st May, 1941, in relation to the Scheme prepared by the River Great Ouse Catchment Board, under Section 4 (1) (b) of the Act, making provision for the following matters:—

(1) The alteration and extension of the boundaries of the Stoke Ferry Drainage District;

(2) The abolition of the Stoke Ferry Drainage Commissioners;

(3) The constitution of the Stoke Ferry Drainage District as so altered and extended as an Internal Drainage District and of the Drainage Board therefor;

(4) The abrogation of the powers of the Commissioners of Sewers for the County of Norfolk within the said Stoke Ferry Internal Drainage District;

(5) Certain matters supplemental thereto or consequential thereon

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not have been complied with, may quash the Order either generally or in so far as it affects the applicant.
