ROAD AND RAIL TRAFFIC ACT, 1933.

NOTICE is hereby given that on the 5th November, 1940, the Minister of Transport confirmed the administrative County of West Sussex (Roads Restriction) (No. 1) Order 1940, made by the West Sussex County Council under Section 46 (i) of the Road Traffic Act, 1930, and Section 29 of the Road and Rail Traffic Act, 1933. The Order provides that no person shall drive any vehicle the weight of which whether laden or unladen exceeds three tons on so much of the Chichester-Bognor Road (A259) as is carried by the Bognor Road Railway Bridge in the City of Chichester.

SPECIAL ENACTMENTS (EXTENSION OF TIME)
ACT, 1940.

THE Minister of War Transport has made the Darlington Corporation (Extension of Time) Order, 1941 (S.R. & O. 1941 No. 863), extending by three years the time limited for the commencement of the running of trolley vehicles along Routes No. 1, 2 and 3 authorised by Section 3 of the Darlington Corporation Trolley Vehicles (Additional Routes) Order, 1936.
