

SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT 1940

THE Minister of War Transport has made the London and North Eastern Railway (Extension of Time) Order, 1941 (S.R. & O. 1941 No. 1450), extending by three years the time limited by—

(a) Section 45 of the London and North Eastern Railway (London Transport) Act 1936 for the completion of certain railways at Finsbury Park in the Metropolitan Borough of Islington.

(b) Section 22 of the London and North Eastern Railway Act 1938 for the compulsory purchase of—

(i) (a) lands in the parish of Whetstone in the rural district of Blaby in the county of Leicester authorised to be acquired by Section 5 of that Act.

(b) lands in the urban district of Hucknall in the county of Nottingham authorised to be acquired by Section 5 of that Act.

(ii) the lands hereafter referred to described in and authorised to be acquired by Section 17 of that Act—

In the County of Essex—

Lands in the borough of Ilford on the east side of the Company's Ilford to Woodford Railway south of Hainault Station;

In the County of Warwick—

Lands in the parishes of Wolfhampcote and Willoughby in the rural district of Rugby and lands in the borough of Rugby;

In the County of Leicester—

Lands in the parish of Shawell in the rural district of Lutterworth;

In the County of Nottingham—

Lands in the parish of Ruddington in the rural district of Basford.

NOTE.—The following diseases were eradicated from Great Britain in the years indicated :— Cattle plague or rinder-pest (*pestis bovina*), 1877; pleuro-pneumonia (*peripneumonia contagiosa bovis*), 1898; sheep pox (*variola ovium*), 1850; rabies, 1922; epizootic lymphangitis (*lymphangitis epizootica*), 1906; and glanders (including farcy) (*malleus*), 1928. Dourine (*exanthema coitale paralyticum*) has never existed in Great Britain.

No case of Fowl Pest (*pestis avium*) has been confirmed in Great Britain since the 11th January, 1937, the date as from which the disease was first notifiable. So far as is known, however, Fowl Pest has not existed in Great Britain since 1933.

TUBERCULOSIS ORDER OF 1938.

Notices of Intended Slaughter have been issued by the Ministry of Agriculture and Fisheries under the Tuberculosis Order of 1938 during the period 1st to 15th September, 1941, in respect of 654 bovine animals.
